Representative Matters

- Bodnar v. Nationwide Ins., 3d Cir. 2016 following an underlying fatality, successfully established insurer did
 not act in bad faith, under Pennsylvania law, by filing action for declaratory judgment to determine coverage
 even after having reached temporary consensus that coverage applied
- Shannon v. New York Central Mutual Ins. Co., U.S. Dist. Ct., M.D. Pa., 2014 recognition of bad faith setup defense asserted against insured
- Orsag v. Farmers New Century Ins., Pa. 2011 successfully obtained opinion from state Supreme Court
 holding that a signed original policy application to the insurer met the requirement for written selection of
 UM/UIM limits lower than bodily injury limits pursuant to 75 Pa. C.S.A. § 1734
