## Two Dickie McCamey Attorneys Appointed to Disciplinary Board

The Disciplinary Board is an independent agency funded by the Supreme Court of Pennsylvania, consisting of 13 members from across the Commonwealth. It assists the Supreme Court in carrying out its exclusive jurisdiction over the licensing and discipline of attorneys in Pennsylvania. The Disciplinary Board's goals are to protect the general public, maintain a high standard of integrity in the legal profession, and safeguard the reputation of the courts of Pennsylvania.

One reason for Mr. Marino's appointment, according to Board Chair Jane G. Penny, is his excellent reputation as a lawyer and premier litigator. He is a shareholder at DMC and an accomplished defense attorney. During his 35-year legal career, Mr. Marino has concentrated his practice in the areas of insurance bad faith/coverage litigation, professional malpractice, premises liability, legal malpractice, and product liability law. He is Chair of Dickie McCamey's Insurance Law and Litigation Group.
